I understand that harvesting is a crucial time in your life and typically absorbs all available resources. For this reason I am prepared to extend your deadline to submit a statement of concern by one week from September 18 to September 25, 2020.

Please keep in mind that the courtesy letter is not our public notice. Public notice was given in the August 20 issue of the Lethbridge Herald. Generally, courtesy letters are sent out to residents and landowners within the identified notification radius to alert them towards the public notice. In addition, the addresses are provided by the respective county and might, at times, not include all residents and/or landowners. For this reason I am not prepared to release the list that was provided by the counties (Lethbridge and Warner) and recommend to contact the counties directly to get the names to all landowners within the notification radius.

However, we always check if the respondents to any of the application do indeed live within the notification radius during the decision making process.
