Subject: Recap of building construction

Hello Karl,

I thought it might be worth while sending you a email with the summary of what we talked about this afternoon.

After sending in my part 2, I was given the date by Adria that Nov14 the permit would be done. No construction was done prior to this date. RCC was placed Nov14 according to NRCB specs. Adria then via phone told me that the permit wasn't quite done yet, it would be another 2 weeks. After those 2 were almost past, I was told it would be done before Christmas. We started with building the covered shelter beginning of December, still ensuring that the RCC was covered properly. Then I received a phone call that Adria missed a deadline to send the permit it, so that it wouldn't be done before Christmas anymore. She told it would go through the review process during the break, and that she would hand the permit to me Jan 2.

Beginning of January, we moved the first calves into the weaning shelter. Then in February we started putting animals in the corrals. All the while the RCC was covered in a generous layer of straw with some manure spread on top to keep the straw from blowing away.

We then heard from Adria the permit would still take more time.

Then for several months i called almost every other week, and emailed almost every other week to see if there was progress, but Adria never returned my calls and never replied to most of the emails. About a 4-5 weeks ago I emailed Adria and kinda explained how I was a little disappointed with how things were going. She emailed back she would lay all other permits aside and work on mine till it was done.

Things have kinda changed over the last week or 2, hopefully we can get things sorted out and that the process may continue on.
