NRCB Notice Filed Requests for Board Review and Rebuttal Opportunity Decision Summary LA23050 Hutterian Brethren of Ivy Ridge

The Board of the Natural Resources Conservation Board (NRCB) has received six requests for review (RFRs) of an NRCB approval officer's Decision Summary LA23050, issued on January 28, 2025. The decision approved an application by the Hutterian Brethren of Ivy Ridge (Ivy Ridge Colony) to construct a new multi species confined feeding operation (CFO). The proposed CFO location is Sec. 31-14-26 W4M in the Municipal District of Willow Creek.

The RFRs were all filed by directly affected parties and met the February 11, 2025, deadline set out in the approval officer's decision letter. The RFRs are available <u>online</u> on the NRCB website.

Any directly affected party who has an **adverse** interest to the outcomes requested or to the positions presented in the RFR may submit a rebuttal (i.e., a written letter or email) for the Board's consideration (see section 13(4) of the AOPA Administrative Procedures Regulation). Send rebuttals to laura.friend@nrcb.ca by no later than **4:30 p.m. on February 19, 2025.** Rebuttals filed past the deadline are not accepted.
