The permit holder shall comply with the requirements of the *Agricultural Operation Practices Act* (AOPA) and the regulations passed pursuant to that Act.

The permit holder shall adhere to the descriptions, the site plan, building plans, and other attached documents included with filed Application BA24004. Approval BA15002, must also be adhered to unless otherwise noted in the following conditions.

The permit holder shall contact the NRCB at least 10 working days in advance of the desired inspection date to schedule the inspection in condition #3.

#### **Construction conditions**

#### Breeder Barn

1. Construction completion deadline

The permit holder shall complete construction of the breeder barn prior to December 1, 2026. Upon request, this deadline may be extended by the NRCB in writing.

## 2. Concrete

The concrete used to construct the manure collection and storage portion of the breeder barn must meet the specifications for category D (solid manure – dry) in Technical Guideline Agdex 096-93 "Non-Engineered Concrete Liners for Manure Collection and Storage Areas." The permit holder shall provide written proof to the NRCB confirming the specifications of the concrete used. This document must be provided to the NRCB prior to the inspection referenced in condition #3, below, or by a later date stated by the NRCB.

3. Post construction inspections (prior to populating facilities)

The permit holder shall not place livestock or manure in the breeds

The permit holder shall not place livestock or manure in the breeder barn until the NRCB has inspected the facility and stated in writing that it has been constructed in accordance with this approval.



This Approval becomes effective immediately. The Approval conditions will remain in effect unless amended in writing by the NRCB.

Approval BA15002 is hereby superseded, and its content consolidated into this Approval BA24004, unless Approval BA24004 is held invalid following a review and decision by the NRCB's board members or by a court, in which case Approval BA15002 will remain in effect.

# **Construction conditions** (brought forward from Approval BA15002)

## New lay barn

# 1. Concrete

The concrete used to construct the manure storage and collection system in the barn must have a minimum 28-day strength of 25 MPa and a maximum water to cement ratio of 0.55. The permit holder shall provide a copy of the concrete supplier's invoice or other proof to the NRCB to confirm the specifications of the concrete used in the construction. This document must be provided to the NRCB prior to the inspection referenced in condition 4 below or by a later date stated by the NRCB.

## 2. Construction completion deadline

The permit holder shall complete construction of the manure collection and storage portions of the barn prior to December 31, 2018. Upon request, this deadline may be extended by the NRCB in writing.

## 3. Notice to the NRCB

The permit holder shall contact the NRCB at least 10 working days in advance of the desired inspection date to schedule the inspection referred to in condition 4 below.

## 4. Post construction inspections (prior to populating facilities)

The permit holder shall not allow livestock in the barn until it has been inspected by NRCB personnel and determined by them, in writing, to have been constructed in accordance with the terms and conditions of this permit.
