## Permitted construction (based on the submitted site plan):

 Replacement of a portion of the concrete liner in existing poultry barn (Barn 18) – 115 .8 m x 5.5 m (380 ft. x 18 ft.)

The permit holder shall comply with the requirements of the *Agricultural Operation Practices Act* (AOPA) and the regulations passed pursuant to that Act.

The permit holder shall adhere to the descriptions, building plans and other attached documents included with filed Application RA24028 and previously issued NRCB Approval RA16033.

The permit holder shall contact the NRCB at least 10 working days in advance of the desired inspection date to schedule the inspection in condition 2.

The permit holder is responsible for all costs associated with monitoring, sampling, testing, recording, and reporting requirements (this includes post construction reports).

#### **Construction conditions**

### New concrete liner (barn 18)

- 1. The concrete used to construct the new liner of the manure collection and storage portions of barn 18 shall meet the specification for category D (solid manure dry) in Technical Guideline Agdex 096-93 "Non-Engineered Concrete Liners for Manure Collection and Storage Areas." The permit holder shall provide documentation to confirm the specifications of the concrete used to construct the manure storage and collection portions of the new concrete liner in barn 18.
- The permit holder shall not allow livestock or manure on the new liner of the manure collection and storage portions of barn 18 until the facility has been inspected by NRCB personnel and confirmed by them, in writing, to have been constructed in accordance with the terms and conditions of this permit.
- 3. The permit holder shall complete construction of the new liner of the manure collection and storage portions in barn 18 prior to May 31, 2025. Upon request, this deadline may be extended by the NRCB in writing.



## **Operating conditions**

4. Water well monitoring and protection:

The permit holder shall conduct water quality tests for chlorides and nitrates (routine water testing) annually, on water well ID #40162 located within 100 meters of the manure storage and collection areas at the CFO, unless otherwise directed in writing by the NRCB.

This approval becomes effective immediately. The approval conditions will remain in effect unless amended in writing by the NRCB.

Approval RA16033 is hereby superseded, and its content consolidated into this Approval RA24028, unless Approval RA24028 is held invalid following a review and decision by the NRCB's board members or by a court, in which case Approval RA16033 will remain in effect.

## **Construction conditions** (brought forward from RA16033 already met)

New Chicken Breeder Barn (Barn 18)

#### 1. Concrete

The concrete used to construct the manure storage and collection system in the new breeder barn must be sulphate resistant and have a minimum 28-day strength of 25 MPa. The permit holder shall provide documentation to confirm the specifications of the concrete used in the construction. This documentation must be provided to the NRCB before the inspection referenced in condition 3 below, or by a later date stated by the NRCB.

## 2. Construction completion deadline

The permit holder shall complete construction of the manure collection and storage portions of the new breeder barn before December 31, 2018. Upon request, this deadline may be extended by the NRCB, in writing.

### 3. Post construction inspection

The permit holder shall not place livestock or manure in the new breeder barn, until it has been inspected by NRCB personnel and determined by them, in writing, to have been constructed in accordance with the terms and conditions of this permit.
