

In consideration of Decision Summary RA24038, Authorization RA24038 is issued to:

Permitted construction (based on the submitted site plan):

- Expansion of pen 1 120 m x 20 m (addition) (existing portion is 76 m x 43 m)
- Pen 4 200 m x 43 m
- Pen 5 200 m x 43 m
- Pen 6 200 m x 43 m
- Lamb building 70 m x 40 m
- Catch basin 180 m x 55 m x 0.5 m deep

The co-permit holders shall comply with the requirements of the *Agricultural Operation Practices Act* (AOPA) and the regulations passed pursuant to that Act.

The co-permit holders shall adhere to the descriptions, the site plan, building plans, engineering reports and other attached documents included with filed Application RA24038.

The co-permit holders shall contact the NRCB at least 10 working days in advance of the desired inspection date to schedule the inspection in conditions 2, 4, 6, 8, 10, and 12.

Construction conditions

Expanded pen 1

- 1. Construction completion deadline
 The co-permit holders shall complete construction of the expanded portion of pen 1 prior to
 December 1, 2027. Upon request, this deadline may be extended by the NRCB in writing.
- Post construction inspections (prior to populating facilities)
 The co-permit holders shall not place livestock or manure in the expanded portion of pen 1 until the NRCB has inspected the facility and stated in writing that it has been constructed in accordance with this authorization.

Pen 4

- Construction completion deadline
 The co-permit holders shall complete construction of pen 4 prior to December 1, 2027.
 Upon request, this deadline may be extended by the NRCB in writing.
- 4. Post construction inspections (prior to populating facilities)
 The co-permit holders shall not place livestock or manure in pen 4 until the NRCB has inspected the facility and stated in writing that it has been constructed in accordance with this authorization.



Pen 5

5. Construction completion deadline
The co-permit holders shall complete construction of pen 5 prior to December 1, 2027.
Upon request, this deadline may be extended by the NRCB in writing.

6. Post construction inspections (prior to populating facilities)
The co-permit holders shall not place livestock or manure in pen 5 until the NRCB has inspected the facility and stated in writing that it has been constructed in accordance with this authorization.

Pen 6

7. Construction completion deadline

The co-permit holders shall complete construction of pen 6 prior to December 1, 2027. Upon request, this deadline may be extended by the NRCB in writing.

8. Post construction inspections (prior to populating facilities)
The co-permit holders shall not place livestock or manure in pen 6 until the NRCB has inspected the facility and stated in writing that it has been constructed in accordance with this authorization.

Catch basin

9. Construction completion deadline

The co-permit holders shall complete construction of the catch basin prior to December 1, 2027. Upon request, this deadline may be extended by the NRCB in writing.

10. Post construction inspections (prior to populating facilities)

The co-permit holders shall not allow manure impacted runoff to enter the catch basin until the NRCB has inspected the facility and stated in writing that it has been constructed in accordance with this authorization.

Lamb building

11. Construction completion deadline

The co-permit holders shall complete construction of the lamb building prior to December 1, 2027. Upon request, this deadline may be extended by the NRCB in writing.

12. Post construction inspections (prior to populating facilities)

The co-permit holders shall not place livestock or manure in the lamb building until the NRCB has inspected the facility and stated in writing that it has been constructed in accordance with this authorization.



This authorization becomes effective immediately and needs to be read in conjunction with previously issued Registration RA23003. The authorization conditions will remain in effect unless amended in writing by the NRCB.
